

Consent to the processing of personal data of individual clients

The user, by leaving an application or feedback on the website www.anadolumedicalcenter.ua, accepts this consent to the processing of personal data (hereinafter — Consent). Acting freely, of his own will and in his own interest, as well as confirming his legal capacity, the User gives his consent to Anadolu Medical Center (ANADOLU EGITIM VE SOSYAL YARDIM VAKFI SAGLIK TESISLERI IKTISADI ISLETMESI), which is located at: Republic of Turkey Jumuriyet Mahallesi 2255 Sokak No.3, Gebze, 41400, Kocaeli, to process your personal data with the following conditions:

1. This Consent is given for the processing of personal data, both without the use of automation tools and with their use, by transmission through open Internet communication channels.

2. I consent to the processing of my personal data:

1) Personal data that are biometric: surname, first name, contact phone numbers; city of residence, e-mail addresses; data about my state of health, diseases, cases of seeking medical help for medical and preventive purposes; user data; location information; OS type and version; Browser type and version; device type and screen resolution; the source from which the user came to the site; from which site or for which advertisement; OS and Browser language; which pages are opened and to which buttons are pressed by the user;

3. Personal data is publicly available.

4. The purpose of processing personal data: providing a "second opinion" (an independent opinion of doctors about the recommended treatment and the possibility of its implementation at the Anadolu Medical Center) and a preliminary calculation of the cost of services, making an appointment, providing general information about the work and services of the Anadolu Medical Center, receiving complaints, suggestions and recommendations, analyzing the actions of a natural person on the website and the functioning of the website.

5. During the processing of personal data, the following actions will be performed: collection; record; systematization; accumulation; storage; clarification (update, change); withdrawal; using; transmission (distribution, provision, access); locking; removal; destruction.

6. Personal data received through the submission of an application or feedback on the website www.anadolumedicalcenter.ua may be transferred to organizations or third parties related to the implementation of the goals specified in clause 4 through open (unsecured) Internet communication channels.

7. Processing of personal data may be terminated at the request of the subject of personal data. Storage of personal data, recorded on paper media, is carried out by protected technical systems and means of data storage. The technical systems and personal data storage facilities used in the Anadolu Medical Center (ANADOLU EGITIM VE SOSYAL YARDIM VAKFI SAGLIK TESISLERI IKTISADI ISLETMESI) have a high level of protection in accordance with security regulations and requirements.

8. Consent may be revoked by the subject of personal data or his representative by sending a written application to the Medical Center of Anadolu (ANADOLU EGITIM VE SOSYAL YARDIM VAKFI SAGLIK TESISLERI IKTISADI ISLETMESI) at the address indicated at the beginning of this Agreement.

9. This Agreement is valid all the time until the termination of the processing of personal data specified in clauses 7 and 8 of this Agreement.
